**PAYMENT DEADLINES**

<b><u>Due date:</u> October 25, 2022</b>	Full payment for each chapter’s total registration must be <b><u>RECEIVED</u></b> by the FBLA Treasurer by October 25. Hand deliveries and deliveries with signature required will NOT be accepted.  <i>Clarification:</i> This does NOT mean the payment can be <i>mailed</i> by October 25. This means <b><u>the payment must be RECEIVED by the FBLA Treasurer by October 25.</u></b> It is the chapter advisor’s responsibility to make arrangements with their school’s finance office to ensure payment will be issued in time to meet this deadline.
October 26 – November 2, 2022	Payments received during this period, including payments made at the conference, are subject to a \$50 late fee. Please add \$50 to your payment.
After November 2, 2022	Payments received after the conference are subject to a \$100 late fee and may impact the chapter’s eligibility to register and compete at their Regional Conference. Please add \$100 to your payment.

**\*\*\$75 payment per attendee is if payment is made by school check.**
