From this point please begin to populate the information requested and once complete hit the submit button. As with the State conference, you will receive an invoice from the registration site and we will acknowledge your reservation as well.

It is the responsibility of each advisor to register your chapter and students for the NLC with National FBLA no later than Monday, May 16th in order to take advantage of the earlier bird pricing otherwise your cost per person will increase.

Once you complete that process, please keep a copy of the registration information and email it to my attention so I can keep track of who has registered and who has not as well as for future use, should you need to refer back to this form.

It is only the responsibility of Vista Travel to collect the NLC Registration Fees and pay for the conference registration once you have registered with National FBLA and we have received your confirmation.

In the past there has been some confusion with the schools sending in a check for the NLC registration. **That is not necessary as Vista Travel collects the funds as it is built into the trip program already.** Vista Travel will pay for the conference registration in full by the due date.
